5. **AGE:**

- i. OC candidate should not have completed 42 years as on date of Notification (should not have been born before 01-07-1981).
- ii. EWS/SC/ST/BC candidates should not have completed 47 years as on date of Notification (should not have been born before (01-07-1976)
- iii. Differently abled persons should not have completed 52 years as on date of Notification (should not have been born before (01-07-1971)
- iv. Ex-service men should not have completed 50 years as on date of Notification (should not have born before (01-07-1973)

6. **Selection Procedure:**

- a. Merit list will be prepared with the candidatures of all the applicants who attended Walk-In-Recruitment based on the following marks matrix.
- b. Total Marks: 100.
- c. 75% of the marks obtained in PG Degree / DNB
- d. In the absence of PG marks memo, marks obtained in PG Degree / DNB will be considered as 50%. 75% of 50 i.e., 37.50 will be taken for reckoning. It is the responsibility of the candidate to obtain and submit marks memos from the competent authorities where ever grades instead of marks are issued.
- e. Calculation in-respect of Grades: As per Govt., Memo.No.4298/A1/2015, HM&FW(A1) Dept., dt.22.04.2015.

a) Grade–A	Distinction	75% to 85%	Mean 80%

- f. Waiting period Weightage : Maximum of 10 marks @ 1.0 mark per completed year from the date of passing of qualifying examination to the date of issue of notification.
- g. Weightage for contract service up to 15% will be given to the candidates working / worked on Contract / Outsourcing / Honorarium basis including COVID-19 service as shown below subject to satisfactory service, certified by the competent authority, as per GO.Rt.No.211, HM& FW(B2) Dept., Dt:08.05.2021, G.O.Rt.No.573 HM&FW (B2) Dept. dt.01.11.2021 and GO.Rt.No.07 HM&FW (B2) dept. Dt.06.01.2022, Govt.Memo.No.3740784/B2/2020 of HM&FW (B2) Dept., dt.14.02.2022 & Read with circular No.03/CHFW/2022, dated. 11.02.2022 of the Commissioner of Health & Family Welfare, A.P. If any individual worked less than six months for COVID, the weightage shall be 0.83 marks per completed month will be awarded.

7. **Weightage to contract service based on type of area:**

- a. @ 2.5 marks per six months in Tribal Area.
- b. @ 2.0 marks per six months in Rural Area.
- c. @ 1.0 marks per six months in Urban Area.
- d. No weightage will be given for the services less than six months.
- e. Spells of service rendered will also be considered.
- h. The Specialist doctors (CASS) who have been working / worked on contract /outsourcing/ Honorarium basis and discontinued for administrative reasons i.e. for want of vacancy will be eligible for contract weightage.

- i. The COVID-19 weightage shall be applicable only to the persons who were appointed by a competent authority authorized under the relevant COVID orders /GOs and are appointed by District Collector or any other competent authority based on orders issued by Government from time to time and certified by the controlling officers (DMHO / DCHS/ Superintendent of GGH) to that effect as per G.O.Rt.No.211, HM&FW (B2) Dept., Dt:08.05.2021, G.O.Rt.No.573, HM&FW (B2) dept., dt.01.11.2021 and G.O.Rt.No.07, HM&FW (B2) dept., dt.06.01.2022, Govt.Memo.No.3740784/B2/2020 of HM&FW (B2) Dept., dt.14.02.2022 & read with circular no.03/CHFW/2022, dated.11.02.2022 of the Commissioner of Health & Family Welfare, A.P. COVID weightage will be considered on submission of appointment orders for COVID-19 Management, Monthly attendance certificates and Bank statements indicating payment of monthly remuneration along with COVID service certificate.
- j. Contract service will be reckoned upto the date of notification as per Govt.Memo.no.4274/D1/2013, HM&FW(D1) Dept., dt.10.07.2014.

**8. HOW TO APPLY:**

- Candidates shall submit the application by attending walk in recruitment in physical mode and along with the following original certificates and one set of Xerox copies.
  - a. Latest passport-size photo\*
  - b. SSC Certificates (proof of date of birth)\*
  - c. Intermediate certificate\*
  - d. MBBS Degree Certificate\*
  - e. PG Degree Certificate/Super-Specialty degree certificate\*
  - f. PG degree marks memo/Super-Specialty degree marks memo\*
  - g. Medical Council Registration Certificate\*
  - h. Candidates, who claim for VH/MH/HH/OH vacancy, must submit Disability Certificate to that extent, issued by the concerned medical board or SADAREM.
  - i. Caste Certificate in case of SC/ST/BC or Social Status (for candidates claiming EWS) Certificate issued by Competent authority. If caste certificate is NOT submitted, then such a candidate is considered as OC.

**9. Important information to Candidates :**

- a. Candidates undergoing PG / Super Specialty course are advised not to apply. Permission will not be given to continue their PG / SuperSpecialty course under any circumstances, if selected.
  - b. Selected candidates will be posted to any medical institution as per requirement of the Department.
  - c. If selected, he/she should stay at the bonafide Head Quarters compulsorily.
10. The recruitment is subject to outcome of any O.As / W.Ps pending before Court and likely to arise in the matter.
