1. Educational (Academic, Professional, Technical) qualifications, nature of appointment and remuneration to various posts:

 - iii. @ 1.0 marks per six months in Urban Areas
 - No weight age will be given for the services less than six months for Non-COVID Service.
- f. The COVID-19 weight age shall be applicable only to the persons who have rendered their services for COVID-19 on contract/Outsourcing/Honorarium basis and are appointed by the District Collector or any time to time and certified by the controlling officers (DMHO/DCHS/Principal GMC/Superintendent of GGH) to that effect.

- g. 4. Tenure of appointment and important conditions:

The tenure for the contract/outsourcing posts is initially one year from the date of joining in the post and may be extended for further period as per the instructions issued by the Government from time to time. The District Selection Committee reserves all the rights to terminate the contract /Outsourcing services all the rights to terminate the contract/outsourcing services of any candidate/Candidates at any time with one month notice or as per directions of the Government from time to time.

- i. Certificate of disability issued in SADAREM.
- j. Service certificate from the controlling officer concerned (DM&HO/DCHS/Principals of GMCs/Superintendent of GGH / Any weight age for Contract/ Outsourcing/ Honorary service, in the absence of which the candidate will not be given service weight age (Proforma is herewith enclosed).
- Any other certificates as relevant and applicable.

6. Important information to candidates:

- a. If selected, he/she should stay at the bonafied Head Quarters compulsorily.
- b. If selected and appointed he/she should be abide by the Government rules in force regularly from time to time.

7. DEBARMENT:
